The integrated public-facing trial is a full-scale dress rehearsal of what a typical day at the airport will look and feel like. It's a voluntary opportunity to test, shape and influence the new PIT experience before we officially open. Participants will act as passengers and move through the new terminal and parking garage, and provide feedback that will directly help us enhance and improve the PIT experience for everyone.

Basic, Advanced and Integrated Trials and Special Events Set

As we move closer to our fall opening of the new PIT, key tests and special event dates have been added to our calendar to assist with preparation. ORAT Champions will provide insights and additional details to every team on every shift in the coming weeks, but for general awareness:

Basic Trials:

These trials include tests of 35+ business areas. Conducted on-site, they are designed to test operational functions, including operational flows for passengers, baggage, aircraft, personnel, goods and waste. Some have already happened and more are being scheduled.

Emergency Response Drill (mass-casualty, full-scale exercise involving an active shooter scenario): September 9, 2025

Emergency response drills are not new to PIT, but the opportunity to conduct this drill in the new terminal before it's occupied is both unique and important.

ACAA Family and Friends Open House: September 13, 2025

Before other opening events for the public, this event will provide a critical opportunity to see the new terminal in its near-final stages for employees, their friends and families.

Integrated Trial: September 2025

Employee Parking Moves Underway

As part of the transition to our new airport, almost all ACAA and PIT campus team member parking locations will be changing. These changes are intended to provide a better overall experience for everyone.

Lot reassignments will follow a phased schedule to smooth this transition over several weeks and ensure that almost all employees have moved to their go-forward parking location before Day One.

The first set of lot reassignments began on July 8, with concessions team members shifting to the Extended (Shuttle) Lot. Subsequent moves to that lot are tentatively scheduled for the following weeks.

Each group will receive the timing and all details related to their move in advance. Specifics will be made available on the *Get ready, PIT!* microsite, News You Need, and Campus Partner Update, as well as through your manager and ORAT Champions. Your awareness of this information will help make your move seamless and avoid disruption to your workday.

This change is being handled as a “hard cutover,” which means that your airport-issued badge or access card will only operate the gate in the Extended (Shuttle) Lot as of your group's transition date. Employees will not be able to access this lot before that date.

As of Day One, the Extended (Shuttle) Lot will become the dedicated Employee Shuttle Lot and offer more convenient access to the terminal for all team members. Until then, passenger use of this lot will be regulated to maintain availability of spaces for employees.
